



## CONSERVATION TILLAGE EQUIPMENT RENTAL AGREEMENT

This Rental Agreement is entered into by and between the Anderson Soil & Water Conservation District AND

This Rental Agreement covers the rental of the conservation no-till drill **"as is" and "with all faults" and on the terms provided below:**

**RENTAL TERMS: Deposit - \$250 (cash/card+ 3.5% fee) or \$500 (check). Only to be used for cropland or pastureland. Under no circumstances can this grain drill be used for food plots! If it is used for food plots, the renter will forfeit their deposit.** INITIAL: \_\_\_\_\_

The Renter acknowledges and agrees that he/she has inspected the equipment, that he/she relies on that inspection and his/her experience and judgment, not on any oral representation of the District or agents and that (1) the equipment **as is and with all faults** is suitable for his/her purposes and has examined it to see if it is broken upon receipt, at which point he/she must call the office prior to using the equipment. The Renter agrees to use this equipment in a careful and prudent manner and to **reimburse** the District the value of the equipment in the event it is lost or damaged during the period of this Rental Agreement. **The Renter agrees to provide daily maintenance on the equipment including daily lubrication and small repairs.** INITIAL: \_\_\_\_\_

The Renter acknowledges that if the **equipment becomes broken while in use**, he/she must **call the office immediately** and the office will arrange to have the equipment fixed. If the renter decides to fix the problem, he/she does it at his/her own expense and will not be reimbursed for labor. The district will pay for any part needed to fix the equipment as long as the renter calls the office before fixing the equipment and brings the receipt for part and the damaged part to the office. **The Renter must pick up and return the grain drill at STEC Equipment during office hours (8:00 am – 5:00 pm, M-F). Failure to return on the agreed day will result in a \$100 late fee. Housed at 405 McGee Road, Anderson SC 29625** INITIAL: \_\_\_\_\_

The Renter acknowledges he/she is responsible for providing his/her own **3 1/4" hitch pin** (no ball trailer hitch). INITIAL: \_\_\_\_\_

**ASWCD reserves the right to NOT enter into a rental agreement with anyone, at any time, for any reason based on, but not limited to past use and/or abuse of this equipment.**

**We accept cash, check, or credit card payment to Anderson Soil & Water at our office to Pamela Richey, District Manager, only.**

Renter acknowledges there will be a deposit of \$500 (check) or \$250 (cash or card).

Renter will be charged:     \$20/acre (1-10 acres)  
                                     \$18/acre (11-20 acres)  
                                     \$15/acre (21 and above)

There is a \$150.00 minimum. \*\*Under no circumstances will one renter be allowed to retain use of the equipment for more than three (3) consecutive working days \*\* The deposit will be applied to the acres planted. In the event the drill is returned damaged or with seed still in the boxes the renter will forfeit their deposit

**PLEASE MAKE SURE ALL SEED IS REMOVED FROM SEED BOXES. DO NOT USE WATER TO CLEAN THE BOXES. MUST BE VACUUMED.**

**PLEASE LUBRICATE THE EQUIPMENT BEFORE OPERATING**
